



LIFETIME LIMITED WARRANTY

Mid Atlantic Vinyl Products warrants to the original consumer purchaser that its vinyl fencing and railing products are free of defects in workmanship and materials and that, in the course of normal and proper use, its vinyl products will not chip, peel, blister, flake, be damaged by pests or have abnormal weathering colorations. Gate workmanship, including welds, is warranted for a period of two years. Custom gates do not carry a warranty. Mid Atlantic Vinyl Products warrants only those products manufactured by its facilities. This warranty extends only to the original consumer purchaser and is not transferable.

Owner must give prompt notice of any defect to warranty service. Within 30 days of discovery of the claimed defect the owner must contact the dealer who sold or installed the fence or railing, or write to: Mid Atlantic Vinyl Products 5109 Commonwealth Drive Fredericksburg, VA 22407. Proof of purchase is required when requesting warranty service.

The product must be purchased from Mid Atlantic Vinyl Products, or an authorized Mid Atlantic Vinyl Products' distributor or dealer and installed according to installation guidelines and in accordance with codes and restrictions.

This limited warranty if any of the following occurs with respect to the product (a) improper installation, (b) misuse, abuse, neglect, vandalism, accident, or alteration, (c) lack of proper maintenance, (d) impact of foreign objects, (e) contact with solvents, epoxies, glues, paints, chemicals, or other substances. Damages attributable to fire, violent storms, earthquake, ground movement, tornado, hurricane, or acts of God are not covered in any way under this warranty.

This warranty is void if all structural parts or components were not supplied by Mid Atlantic Vinyl Products.

If fence or railing materials are found to be defective and covered by this warranty, Mid Atlantic Vinyl Products will at its discretion either repair or replace the defective materials, or in the event of product non-availability, provide financial compensation equal to the original purchase price of the defective vinyl material.

Mid Atlantic Vinyl Products does not recommend or approve this product for all possible end use applications. Your local Code Authority should be consulted regarding its safety and applicability for intended usage. This warranty gives you specific legal rights and you may also have other rights which vary from state to state.

THE WARRANTY STATEMENTS CONTAINED IN THIS LIMITED WARRANTY SET FORTH THE ONLY EXPRESS WARRANTIES EXTENDED BY MID ATLANTIC VINYL PRODUCTS FOR ITS VINYL FENCE AND RAILING PRODUCTS. THE PROVISIONS OF THIS WARRANTY SHALL CONSTITUTE THE ENTIRE LIABILITY OF MID ATLANTIC VINYL PRODUCTS, AND THE PROPERTY OWNER'S EXCLUSIVE REMEDY FOR BREACH OF THE WARRANTY, MID ATLANTIC VINYL PRODUCTS DISCLAIMS ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE.
